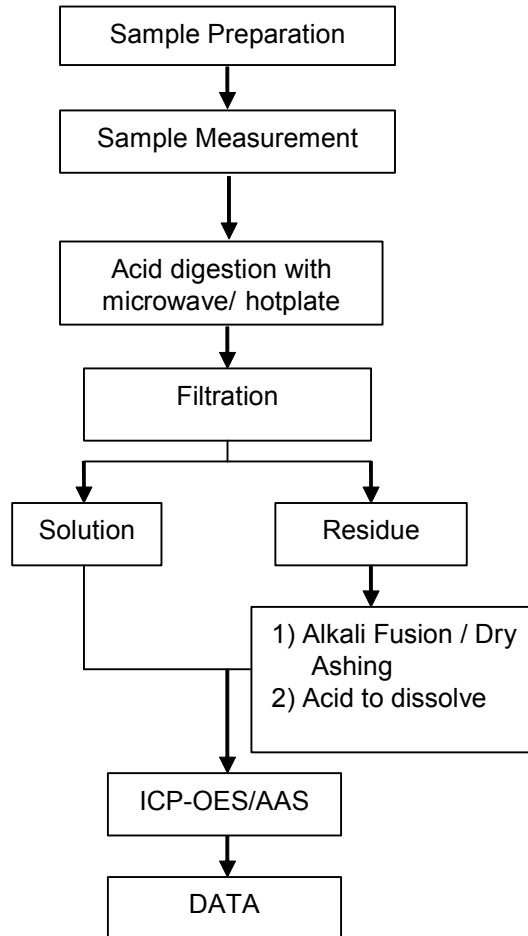

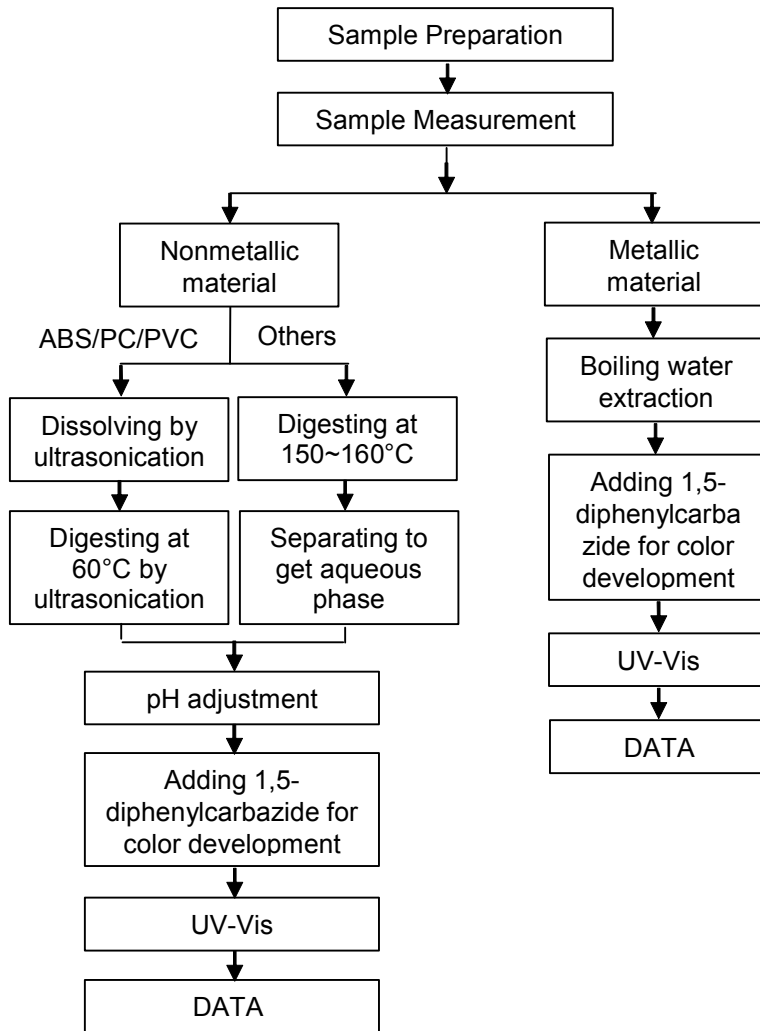

Hexavalent Chromium (Cr(VI)) Testing Flow Chart

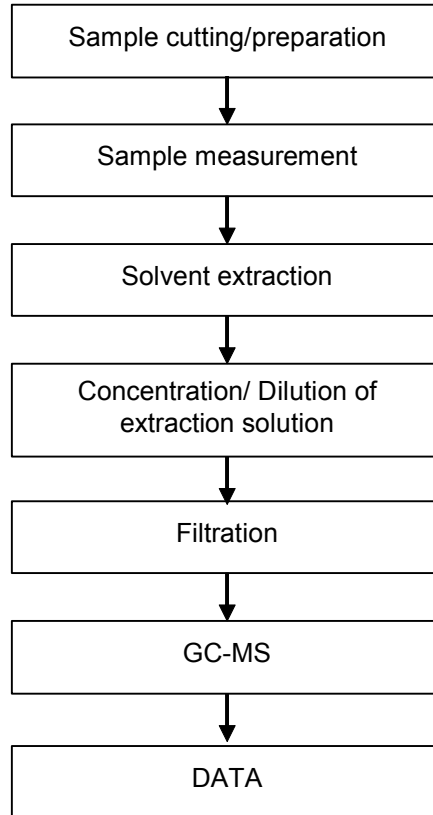

**PBBs/PBDEs Testing Flow Chart**



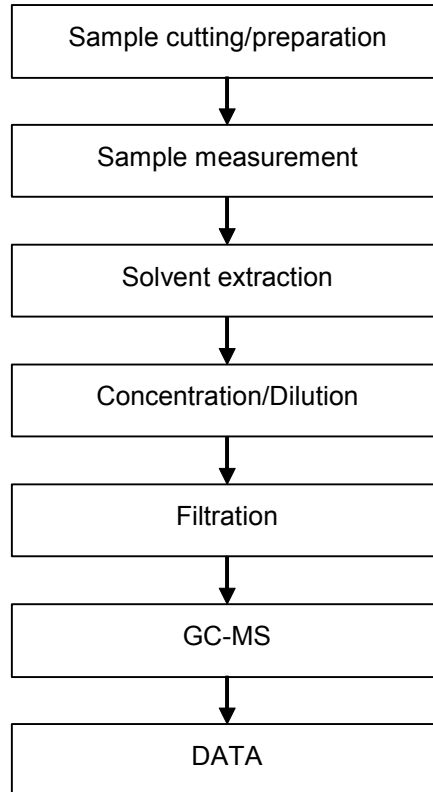

### Phthalates Testing Flow Chart

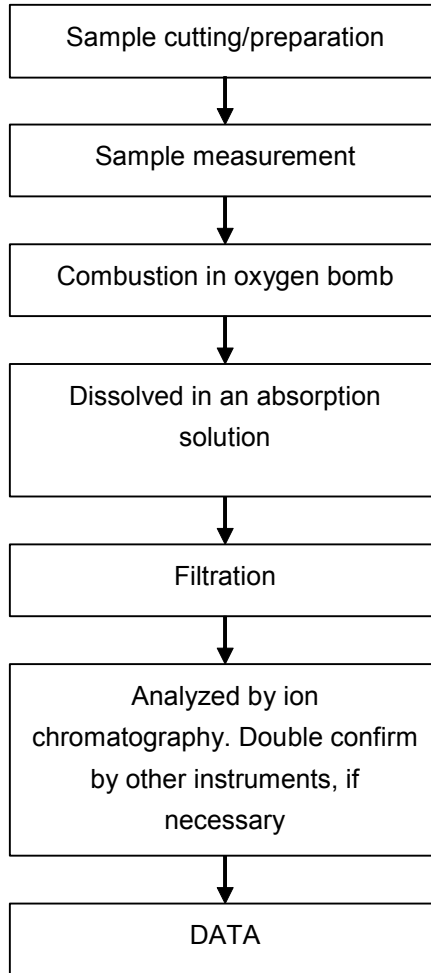

**Halogen Testing (oxygen bomb) Flow Chart**

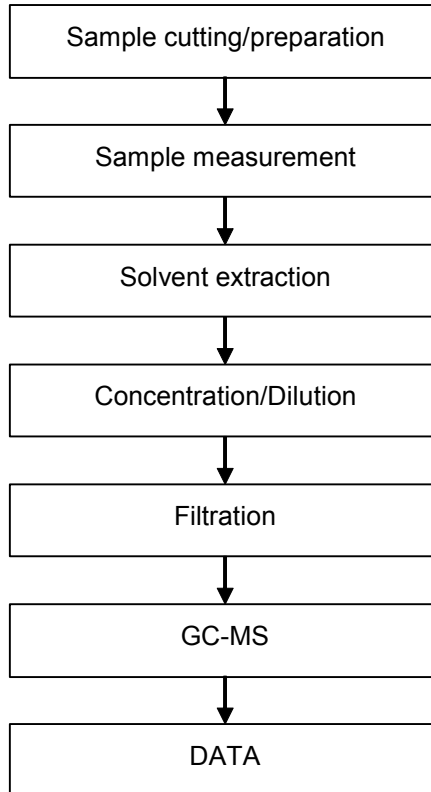

**HBCDD Testing Flow Chart**

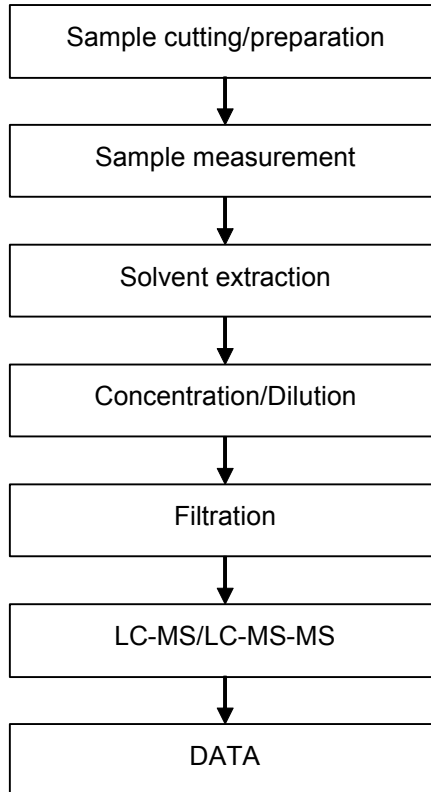

**PFASs/ PFOS/PFOA Testing Flow Chart**

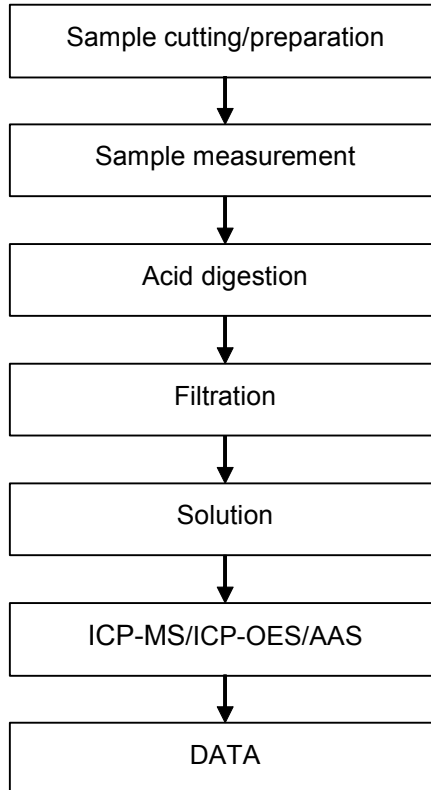

Elements Testing Flow Chart

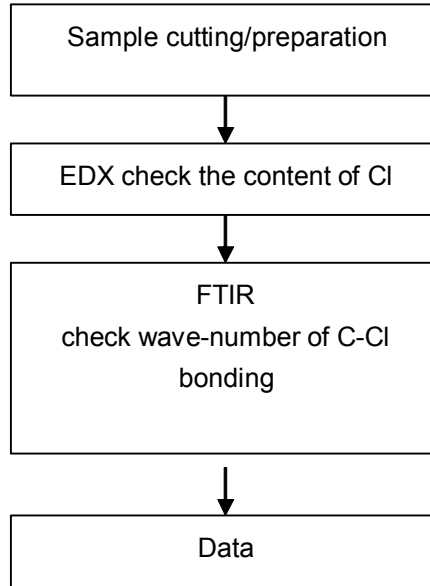

### PVC Testing Flow Chart

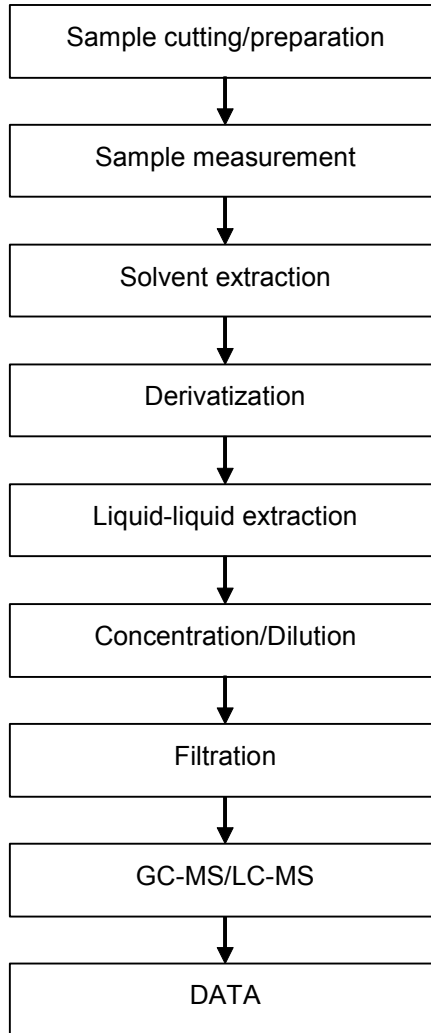

**TBBP-A Testing Flow Chart**

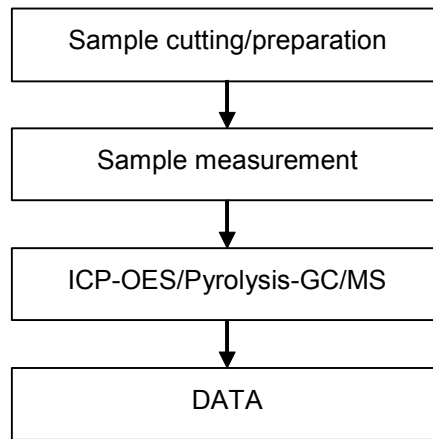
